Why Attend

The Canadian legislative landscape is continuously shaped and altered by decisions of the higher courts. Maintaining professional currency, in particular where specialized skills are identified within a prescribed professional standard, is part of our professional responsibilities.

The area of fire investigations has become a significant bounty for legal challenges south of our border. One only has to read the details stemming from various 'Innocence' initiatives to see how 'bad science' and expert evidence has contributed to wrongful convictions.

Keeping current with Canadian 'Gatekeeper' expectations, challenging science, complex and evolving investigative protocols represents a significant challenge and stress for staff that face the prospect of satisfying the courts that they meet or exceed the expert qualifications. Fire investigations are an important part of your risk/loss mitigation model and maximizing their value will help your business succeed while minimizing the professional exposure of staff to the legal system.

Presenter BIO

Chris Williams, retired OFM Manager from 31 years within provincial law enforcement. Through the course of 20 years with the Office of the Fire Marshal, he invested heavily in the professionalization of staff. He led the re-design and implementation of the OFM fire investigator program to meet and certify to *NFPA 1033 Standard for Professional Qualifications for Fire Investigator* and has significant public speaking experience with professional fire services associations and public safety organizations.

Upon retirement in early 2017, he joined the program development team of Laurentian University where he's currently developing a university credit course in fire investigations. This program will be certified by the OFMEM to the *NFPA 1033 Standard for Professional Qualifications for Fire Investigator, 2014*.
